CASE Plan Values

- Ending homelessness is the responsibility of the community –
everyone has a role to play.
- When not preventable, homelessness should exist for the
shortest time possible
- Manage for positive outcomes that are client-focused and data-
driven
- Consumers must be involved in the decision-making process,
including case plan development, implementation, and
evaluation
- Use best practice models to meet the needs of our community

Prevention Strategies

- ☞ Increase agency/public sector **resources and collaboration** for homeless prevention activities.
- ☞ Provide **short-term emergency assistance** to help people maintain stable housing.
- ☞ Coordinate **discharge planning** from mainstream and homeless service systems
- ☞ Increase the supply of **affordable housing**.

Coordination Strategies

- ☞ Develop **program standards** for homeless service providers and programs
- ☞ Develop **centralized intake system** to gather consistent verifiable information,
- ☞ Develop **case management standards**
- ☞ Explore feasibility of **centralized case management**
- ☞ Enhance **HMIS data collection** in all organizations serving homeless persons and families

Affordable Housing Strategies

- ☞ Make **current rental housing** stock affordable and accessible.
- ☞ Preserve **current public and federally assisted housing** units in Lucas County
- ☞ Secure **additional housing subsidies** for those most at risk of remaining homeless
- ☞ Assist developers with **gap financing** to complement the Low-Income Housing Tax Credit

Communication and Oversight Strategies

- ☞ Support **Continuum of Care planning** structure
- ☞ Focus on **resource development** for new initiatives and ongoing programming
- ☞ Use data to **manage for positive outcomes**
