Community Engagement

Objective #1 - TLCHB

- Secure \$'s to neighborhoods to prevent unstable households
- Service map 'where do I send someone in my neighborhood for services'
- Appropriate outreach intervention: trained counselors by neighborhood
- Increase TLCHB capacity to manage above

Objective #2 TAAEH

- Organization effectiveness is on the upswing however only as good as participants willing to do good work
- Educate stakeholders & utilize new skills identified
- Set broad standards for services
- Job-training to create stability for those at risk; small business engaged
- Service each other

Objective #3 Stakeholders

- Leverage resources / reduce duplication
- Paid staff to work with people
- Funding plan to sustain program
- Affordable housing (tax elements as a consideration)
- "" (part of a larger community agenda)
- Acknowledgement that homelessness needs to be addressed as part of the planning process
- Have a realistic time frame on \$'s
- Reduced paperwork Centralized User Friendly System
- Dissemination of resources and information 'on the street' and neighborhood level
- Service funding that leads to transformation

Consumer Group

A consumer group (consumer) will begin meeting monthly as a committee of TAAEH.

In addition to organizing details, the committee will look at the three areas of need noted at break-out session: Transportation; Education (minimum-GED); Peer Support

Coordinated Services

Centralize & Consistent Intake: Necessary & Highly Valued

- Hand-off clients access appropriate and effective services efficiently
- Mobile and include follow-up otherwise to move beyond being a 'rescue-squad' only

Medical / Nursing Home

- Primary Care coordinated with follow-up
- Physicians Education on homelessness issues and prevention
- Preventive medical care needs to be a part of the 'care' system

Standards (Continuum of Care participation /Services Delivery)

- Outcome focused with quality reporting and tracking component (HMIS)
- Comparative outcomes analysis
- Qualitative emphasis / face-to-face interviews

Supportive Services

- Professional and fully funded
- Community Building Emphasis

Technology

- Maximize current technology capacity (HMIS Training / Client Referral & Follow-up)

Homelessness Prevention

Assist those at imminent risk of homelessness -

- View from 2014
 - More jobs / training /education
 - o Affordable Housing w/more choice & more units including 4-5 bed-room units
 - \circ 1^{st} option Prevention less shelter
 - o More long-term support housing
 - o No waiting for MH services
 - o Safer neighborhoods
 - Centralized / unified Assessment
 - One stop shop for services / homelessness prevention and homeless services
 - No domestic violence
 - o Empowered people

Needs:

- Definition of 'imminent risk'
- Points of particular concern:
 - o Eviction (prevention)
 - o Transition out of shelter / transitional housing
 - o Transition out of institutions (foster care / nursing home / health / corrections)
- Adequate Community Response
 - \circ NIMBY
 - Sexual Offenders
 - Lack of support systems / housing single individuals primarily single male
- Progress:
 - o Discharge Policy sub-committee has been formed
 - o Identify discharge policy barriers
 - o Common Intake assessment tool needed

Sustainable Affordable Housing

- *View from 2014*
 - Toledo Lucas County Housing Trust Fund has a secure, dedicated revenue stream \$2M/yr
 - LMHA has replaced 400 units of traditional public housing w/ Housing Choice Vouchers
 - o LMHA waiting list has been eliminated
 - o Re: Foreclosure
 - Banks are lending
 - "Making Home Affordable" a success
 - Renters protected from foreclosure eviction
 - o Ordinance passed re: Habitability Standards of foreclosed properties
 - Neighborhood Stabilization Program proves successful for 'tipping point' neighborhoods
 - o "Pay to Stay" passed
 - o Genesee County model land banking is adopted and successful
 - o Concentrated comprehensive housing is adopted (e.g. NSNN?)
 - Employment in 21st century industries has reduced unemployment to under 5%
 - No waiting for MH services
 - o Safer neighborhoods
 - o Centralized / unified Assessment
 - One stop shop for services / homelessness prevention and homeless services
 - o No domestic violence
 - o Empowered people

How?

- Seek increase in fully-funded Section 8 vouchers
- Family Self Sufficiency program fully-funded & successful
- Local enhancement for youchers for those most at risk of remaining homeless
- Dedicated revenue stream secured for TLCHTF
